They will provide tax support and advice to the Group's network of shadow tax managers and other financial managers on tax matters as appropriate and provide expert tax oversight on material, unusual, or one-off transactions across the Group, ensuring risks are managed and compliance obligations are fully addressed. They will also work closely with the Head of Group Tax - the role supports the design and implementation of corporate restructuring initiatives to optimise the Group's tax profile, reduce risk and improve efficiency.

Principle accountabilities will be in Tax Accounting and Reporting, Tax Projects and Structural Advisory, UK Tax Compliance, Tax Risk Management and Controls, Global Tax Compliance and Governance and Business Partnering.

- A qualified tax practitioner with significant experience of dealing with tax accounting and corporate taxes in general.
