1. Matters Resolved

Proposal No. 1 : Partial Amendment to the Articles of Incorporation to Increase the Total Number of Authorized Shares

Proposal No. 2 : Share Consolidation

Proposal No. 3 : Partial Amendment to the Articles of Incorporation to Abolish the Share Unit System, etc.

Proposal No. 4 : Election of Six Directors
